



## Message from the General Manager COVID-19 Update | June 2, 2020

NAS Team,

Tuesday, June 2, Phase 1 of AEDC Return to Full Capacity (RtFC) operations are continuing.

### KEY UPDATES

- **Upon return to work, all employees should read and review the NAS COVID-19 Return to Work materials and have it documented by their supervisor.**
- We are continuing to work with the AF on limited implementation of the CARES Act Section 3610; additional details are being finalized and will be shared later this week.
- Anyone denied access related to hotspots should immediately call their supervisor for additional instructions **before** departing the installation; it may be possible for access to be granted.
- Tunnel 9 implemented a heightened security posture due to civil unrest in the region. NAS Team members are urged maintain situational awareness while traveling.

### GENERAL UPDATE

#### Phase 1 RtFC Operations

- Phase 1 will result in a significant increase in operations and return to work for a substantial number of NAS employees.
- Employees involved in executing Phase 1 RtFC operations are being notified.
- We currently forecast ramping up operations to the entire NAS workforce by the week of June 15.
- Base access and screening criteria are being modified by the AF. Implementation is planned for this week. Changes will be communicated upon finalization.
- The AEDC Commander's top priority during RtFC Phase 1 remains protecting the health of the workforce.

Governor Bill Lee enacted an extension of the Tennessee State of Emergency declaration which was scheduled to expire on May 18. The revised state of emergency will be in force until June 30. There is no impact on RtFC Phase 1 operations at Arnold AFB.

Maryland Governor Hogan's "stay at home" directive was lifted Friday, May 15. The state transitioned to a Safer at Home public health advisory. Tunnel 9 operations are not affected by this advisory.

California Governor Newsome's "stay at home" order has been in effect since March 19 and has no set end date. NFAC is continuing preparatory "Week Zero" planning for potential reopening upon notification by NASA-Ames leadership.

#### NAS Status

- Arnold AFB is in HPCON Charlie; Tier 2 operations began April 6; RtFC Phase 1 operations began June 1.
- Tunnel 9 is in HPCON Charlie; Tier 2 operations resumed April 27; RtFC Phase 1 operations began June 1.
- The shelter in place order that NFAC is under was scheduled to expire May 31; it has been extended indefinitely.
- Business travel is restricted.

100% screening is being conducted at Arnold AFB. Employees are expected to:

- Comply with social distancing rules (six feet).
- Limit in-person meeting attendees to no more than 10.

- Avoid in-person interactions by conducting engagements by phone, instant messenger, virtual meetings, etc.

**NOTE: NAS employees are required to wear N-95 masks or greater protection when social distancing rules cannot be maintained for work that requires extended interactions.**

Personal masks are required in common areas.

### COVID-19 Information

**NOTE: Tennessee has 15 hotspot counties: Davidson, Hamilton, Hardeman, Knox, Lake, Montgomery, Putnam, Rhea, Robertson, Rutherford, Shelby, Sumner, Tipton, Williamson, and Wilson.**

**NOTE: Alabama, Georgia, and Kentucky hotspot counties are no longer listed on the AEDC Coronavirus website.**

**NOTE: The work on our sites remains critical to National Security and is being conducted in compliance with the AEDC Commander's priorities:**

- **Safeguard the health of the workforce.**
- **Execute the mission to the best of our ability.**
- **Take care of each other.**

Notify your supervisor if you have been tested for COVID-19 and are awaiting results.

Notify your supervisor if you or an immediate family member have:

- A confirmed COVID-19 case.
- Been quarantined.
- Been placed under medical observation.
