



Message from the General Manager COVID-19 Update | June 8, 2020

NAS Team,

Monday, June 8, Phase 1 of AEDC Return to Full Capacity (RtFC) operations are continuing. Beginning today, June 8, NAS COVID-19 Updates will be provided on Mondays, Wednesdays, and Fridays.

KEY UPDATES

- **This week a large number of NAS Team members will be returning to work.**
- **Employees returning to work should read and review the NAS COVID-19 Return to Work materials and have it documented by their supervisor.**
- Screening at the gates is continuing based on a reduced set of criteria.
- NAS Team members should comply with prevailing social distancing guidelines when away from work.
- We finalized work with the AF on an initial, limited implementation of the CARES Act Section 3610; a brief summary will be provided via email and a more detailed communication will be mailed to home addresses this week.
- Anyone denied installation access should immediately call their supervisor **before** departing the installation to determine if access can be coordinated.
- NASA Ames announced transition to Stage 3 of the NASA Response Framework effective June 8. Once NFAC's Mitigation Plan is approved, NFAC "Week Zero" operations can begin; 60% of NFAC employees could return as soon as the week of June 15.

GENERAL UPDATE

Phase 1 RtFC Operations

- Week 2 of the AEDC RtFC Phase 1 will result in a significant increase in operations and a substantial number of NAS employees returning to work.
- We forecast ramping up operations to the entire NAS workforce in TN by the week of June 15.
- The AEDC Commander's top priority during RtFC Phase 1 remains protecting the health of the workforce.

NAS Status

- Arnold AFB is in HPCON Charlie; Tier 2 operations began April 6; RtFC Phase 1 operations began June 1.
- Tunnel 9 is in HPCON Charlie; Tier 2 operations resumed April 27; RtFC Phase 1 operations began June 1.
- NASA Ames announced transition to Stage 3 of the NASA Response Framework which will permit NFAC Week Zero operations to begin.
- Business travel is restricted.

100% screening is being conducted at Arnold AFB. Employees are expected to:

- Comply with social distancing rules (six feet).
- Limit in-person meeting attendees to no more than 10.
- Avoid in-person interactions by conducting engagements by phone, instant messenger, virtual meetings, etc.

NOTE: NAS employees are required to wear N-95 masks or greater protection when social distancing rules cannot be maintained for work that requires extended interactions.

Personal masks are required in common areas.
